Code of Conduct Dulles South Community Moms

Please review our code of conduct. These guidelines are in place so that everyone in the group can be comfortable and so that issues do not become personal, but are simply a matter of following the rules.

HEALTHY KIDS

• If you, your child, or a member of your family is sick (ie: fever, vomiting, diarrhea in the last 24 hours), please refrain from attending any DSCM activity for the health and safety of other members and their children. If your child becomes ill shortly after attending an activity, please let the other members know that their children may have been exposed.

FOR THE KIDS

DSCM activities are meant to be enjoyable and safe events for both parents and children. We respect parenting differences but expect that all children behave appropriately at activities.

- Parents are responsible for their children's behavior at all times.
- Hitting, biting, pushing, scratching, destroying property, and other physically aggressive behavior must be dealt with immediately by the child's parent. It is NOT an option to allow that behavior to continue.
- If these behaviors occur, the mother should temporarily remove her child from the area. After a short time, this child can resume the activity. If the behavior continues, the child and mother should leave for the day. If a child is consistently having behavioral problems that have warranted removal from activities (3 or more times), the mother may be asked to refrain from attending events until the child's behavior has improved to where they can safely interact with other children.

FOR THE MOMS

DSCM is here to support at-home mothers and their children. We support all mothers and recognize that there are different personalities and opinions in our group.

- All member shall be considerate and respectful of other members and their property.
- The DSCM does not tolerate the use of inappropriate language or gestures.
- Members shall refrain from malicious gossip, demeaning comments, or harassment.
- Members shall not misuse the DSCM roster or any of its contents (phone numbers, email addresses, etc.) for home based businesses, solicitation, etc.
- All firearms and weapons should be secured in a safe place, out of reach of children.
- The Executive Board may take action against a member who violates the code of conduct. These actions include:
 - First Offense verbal warning
 - Second Offense written warning
 - Third Offense termination of membership, dues will be forfeited.
